## **Classroom Usability Checklist**

The purpose of this checklist is to identify barriers that may be encountered by people with disabilities during learning activities. This checklist may assist in planning for removal of barriers to accessibility.

All pathways (halls, aisles, etc.) and spaces within the building are at least 36 inches wide.  Comments:			
Public spaces and pathways to access classroom and services are clear and unobstructed by objects or overcrowding of people.  Comments:			
At least one entrance is equipped with an automatic door or door that requires less than 5 lbs. of force to open, and measures at least 36 inches wide with a threshold of less than ¼ inch.  Comments:			
The control button for the automatic door is on the latch side of the door (side with handle) OR is otherwise positioned so that the door may open without interference.  Comments:

The speaker area/podium is level with the floor with clear space at least 36 inches

The beginning and the end of all interior stairs, ramps and level changes within the classroom are marked with a contrasting color at the top and the bottom, AND all steps are clearly marked with contrast tape or paint on the edge of each step.

Handrails are present on at least one side of stairs and ramps AND extend 12 inches beyond the top and bottom riser or ramp segment.  *Score N/A if there are no steps or ramps.  Comments:

Task lighting levels are maintained at 500 lux or greater in areas designated for fine tasks such as reading or writing.  Comments:
